SCOTTISH RUGBY ALLOCATION OF TICKETS FOR INTERNATIONAL MATCHES

Member Club Terms & Conditions

I would draw your attention to the following conditions under which Scottish Rugby agrees to allocate match tickets:

1 All tickets to international rugby fixtures are issued subject to the Terms and Conditions of the original issuing body.

2 Any allocation of match tickets made on behalf of Scottish Rugby to any Full Member club, Associate Member club or other body or organisation is subject to the following additional conditions:-

2.1 Unless with the express written permission of Scottish Rugby, all tickets are issued for the personal use of individual club/organisation members and their immediate family.

2.2 No ticket may be resold by the club/organisation (or those in turn receiving the tickets from the club/organisation) without the express written permission of Scottish Rugby. Clubs shall hereby be granted permission to re-sell match tickets at face value to their members for the purpose of them attending the fixture.

2.3 The club/organisation hereby agrees to ensure that its members are notified of the conditions of issue, including the additional conditions set out herein, in relation to the sale of international match tickets.

2.4 The club/organisation hereby agrees to provide the information required on the member application form and on confirmation of ticket allocation, the seat details of all members and that you have obtained all necessary permissions to provide with the same.

2.5 Scottish Rugby reserves the right to take disciplinary action against any club or body found to be in breach of the original conditions of issue of the match ticket or the supplementary conditions outlined herein. Such disciplinary action may include suspension from future ticket allocations or such other actions as Scottish Rugby deems appropriate in the circumstances.

2.6 The club/organisation hereby agrees that where it is processing personal data on behalf of Scottish Rugby in relation to the allocation of international match tickets to individuals, it will not act or omit to act in any way which is inconsistent with the Data Protection Act 2018 and will comply with the Data Protection Act 2018 as if it were a controller of such personal data in connection with its processing obligations. "Processing", "personal data" and "controller" shall be as defined in the Data Protection Act 2018.
